
SECTION 2. PhilHealth Capitation Fund Management Committee

A Fund Management Committee is hereby Created to be composed of the following with the duties and functions:

Chairman - Chairman of the Sangguniang Panlungsod  
Committee on Health

Members: - City Health Officer  
Section Head of the RHU Nursing Service  
CHO MCP Coordinator  
Barangay Captain/Chairman on Committee on  
Health  
Mayor's Representative  
Barangay Health Worker (BHW)-President

1. To oversee the PhilHealth capitation fund that enters the coffers of the local government
2. To facilitate the needed purchases regarding logistics and supplies of the health facility.
3. To decide on the fund utilization not covered by PhilHealth guidelines



4. To regulate and serve as the governing body of all accredited PhilHealth facility of the city

SECTION 3. Disbursements of Funds.

All funds shall be disbursed by the Office of the City Treasurer in accordance with the sharing scheme as provided for under Section 1 subject however, to prescribed auditing and accounting rules

SECTION 4. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


