“WHEREAS, however, the City Engineer in its 3rd endorsement dated August 3, 2011 has recommended that under BP 220 which was approved last June 21, 1988, low economic housing projects requires for the asphaltting of the major roads and macadam for minor roads;

“WHEREAS, in order to settle these issues, the Body deem it proper to invite technical people from the HLURB-Regional Office No. VII, Cebu City, to shed light on this matter and to conduct an actual inspection at Lopezville Subdivision whether they have complied with the requirements set under BP220.

"Adopted."


