“Third and Final Reading of an Ordinance Creating the Position of Assistant City Government Department Head I/Assistant City Legal Officer with Salary Grade 23 and Legal Assistant II with Salary Grade 12 all under the Office of the City Legal Officer which shall be included in the Approved Regular Staffing Pattern of the City Government and Providing Funds Therefor.

“RESOLVED, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 26

AN ORDINANCE CREATING THE POSITIONS OF ASSISTANT CITY GOVERNMENT DEPARTMENT HEAD I/ASSISTANT CITY LEGAL OFFICER WITH SALARY GRADE 23 AND LEGAL ASSISTANT II WITH SALARY GRADE 12 ALL UNDER THE OFFICE OF THE CITY LEGAL OFFICER WHICH SHALL BE INCLUDED IN THE APPROVED REGULAR STAFFING PATTERN OF THE CITY GOVERNMENT AND PROVIDING FUNDS THEREFOR.

Be it ordained that:

SECTION 1. The positions of Assistant City Government Department Head I/Assistant City Legal Officer with Salary Grade 23 and Legal Assistant II with Salary Grade 12 are hereby created under the office of the City Legal Officer which shall be included in the approved regular staffing pattern of the city government.

SECTION 2. The amount of PHP585,757.00 out of the Unappropriated balance of the 2005 Underestimated IRA of the City is hereby appropriated for the budgetary requirement of the aforementioned positions, broken down as follows:
