The amount of PHP173,060.90 representing savings from the continuing appropriation under the 2015 Economic Development Fund intended for Drainage System at Upper Suba is hereby reverted to the unappropriated balance of the Economic Development Fund and to appropriate the same for the Construction of Concrete Covered Canal at Zamora St., Barangay Suba.
