“RESOLVED, To approve the foregoing request of the Honorable City Mayor.

“RESOLVED FURTHER, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 38

AN ORDINANCE REVERTING THE AMOUNT OF PHP30,308,765.87 REPRESENTING THE CONTINUING APPROPRIATION UNDER THE GENERAL FUND FOR THE INITIAL FUNDING OF THE CONSTRUCTION OF A CITY HALL AT THE GOVERNMENT CENTER TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO REAPPROPRIATE THE SAME FOR VARIOUS PROGRAMS, PROJECTS AND EXPENDITURES OF THE CITY GOVERNMENT OF BAYAWAN.

Be it ordained that:

SECTION 1 The amount of PHP30,308,765.87 representing the continuing appropriation under the General Fund for the Initial Funding of the Construction of a City Hall at the Government Center since, the implementation of the said project is no longer feasible at this time of the year is hereby reverted to the Un-appropriated Balance of the General Fund and to re-appropriate the same for the following, to wit:

Construction of Integrated Bus Terminal	PHP26,308,765.87
Research and Development on Jatropa Curcas (Operating Expenses)	650,000.00
Research and Development on Jatropa Curcas (Acquisition of Laboratory Equipment)	350,000.00
GK Socialized Housing Project	1,000,000.00
Restoration of Bayawan River Dike	1,000,000.00
Kalumboyan-Mandu-ao Road Network	1,000,000.00


SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


