“RESOLVED, To approve the foregoing request of the Honorable City Mayor and to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 39

AN ORDINANCE REVERTING THE AMOUNT OF PHP41,000.00 REPRESENTING SAVINGS FROM THE CONTINUING APPROPRIATION FOR FURNITURE AND FIXTURES OF THE OFFICE OF THE CITY MAYOR TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR THE PURCHASE OF A DIGITAL CAMERA FOR THE INFORMATION TECHNOLOGY SECTION.

Be it ordained that:

SECTION 1. The amount of PHP41,000.00 representing savings from the continuing appropriation for Furniture and Fixtures of the Office of the City Mayor is hereby reverted to the un-appropriated balance of the General Fund and to re-appropriate the same for the purchase of a Digital Camera for the Information Technology Section.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.




