RESOLUTION NO. 343

“WHEREAS, there is need to amend Ordinance No. 58, series of 2008, of this Body, which regulates the use of the Integrated Business Center (IBC) considering that it is not functioning anymore as an integrated terminal with facilities for the operation of establishments that will be part of the economic enterprise of the city;

“WHEREAS, the Body believed that it is best that it will be converted into a hospital considering the need of the local constituents and the neighboring municipalities for a much better health services which is absent in the city;

“WHEREFORE, on motion of Honorable Councilor Tijing and duly seconded by Honorable Councilor Duque, the Council

“RESOLVED, To enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 29

AN ORDINANCE CONVERTING THE USE OF THE BAYAWAN INTEGRATED BUSINESS CENTER INTO A HOSPITAL.

Be it ordained that:

SECTION 1. The use of the Bayawan Integrated Business Center (IBC) is hereby converted into a Hospital.

SECTION. Repealing Clause. This ordinance repeals Ordinance No. 58, series of 2008, of this Body.

SECTION 3. This ordinance shall take effect after compliance with the provisions of R. A. 7160.


