“RESOLVED, to approve the foregoing request of the Honorable City Mayor and to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 40

AN ORDINANCE REVERING THE AMOUNT THE OF PHP110,000.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION OF THE OFFICE OF THE CITY PLANNING AND DEVELOPMENT COORDINATOR FOR MOTOR VEHICLES TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR IT EQUIPMENT AND SOFTWARE IN THE AMOUNT PHP60,000.00 AND FOR TECHNICAL AND SCIENTIFIC EQUIPMENT IN THE AMOUNT OF PHP50,000.00 OF THE SAME OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP110,000.00 representing savings in continuing appropriation of the Office of the City Planning and Development Coordinator for Motor Vehicles is hereby reverted to the Unappropriated Balance of the General Fund and to re-appropriate the same for IT Equipment and

Software in the amount PHP60,000.00 and for Technical and Scientific Equipment in the amount of PHP50,000.00 of the same office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.
