RESOLUTION NO. 371

"WHEREAS, R.A. 6656, An Act To Protect the Security of Tenure of Civil Service Officer and Employees in the implementation of Government Reorganization, provides the security of tenure of the various agencies in the government;

"WHEREAS, by virtue of its conversion into a city, the city of Bayawan has recently adopted a new staffing pattern which shall be followed in its reorganization for the ensuing year 2003;

"WHEREAS, there is a need to create a placement Committee which shall assist the appointing authority in the judicious selection and placement of personnel;

"WHEREFORE, on motion of Honorable Councilor Barte and unanimously seconded by all members present

"RESOLVED, to enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 19

AN ORDINANCE CREATING A PLACEMENT COMMITTEE IN THE CITY OF BAYAWAN WHICH SHALL ASSIST THE APPOINTING AUTHORITY IN THE JUDICIOUS SELECTION AND PLACEMENT OF PERSONNEL.

Be it ordained that:

SECTION 1. A placement Committee is hereby created for the City of Bayawan, Province of Negros Oriental whose function is to assist the appointing authority in the judicious selection and placement of personnel in the city government pursuant to R.A. 6656.

SECTION 2. The Placement Committee is hereby composed of the following, to wit:

- a. Two members appointed by the City Mayor;
- b. A representative of the appointing authority;
- c. Two members duly elected by the employees holding position in the first and second levels of the career service;

- d. A representative from the registered employees association;
- e. Three (3) members from the Sangguniang Panlungsod designated by the Vice Mayor.


SECTION 3. This Ordinance shall take effect after compliance with the provisions of R.A. 7160, the Local Government Code of 1991.


