ORDINANCE NO. 43

AN ORDINANCE RE-APPROPRIATING OF THE AMOUNT OF PHP45,000.00 REPRESENTING SAVINGS IN CURRENT APPROPRIATION FOR FURNITURE AND FIXTURES OF THE OFFICE OF THE CITY CIVIL REGISTRY UNDER THE GENERAL FUND FOR THE VARIOUS EXPENSES OF THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP45,000.00 representing savings in current appropriation for Furniture and Fixtures of the Office of the City Civil Registry under the General Fund is hereby re-appropriated for the following expenses of the said office, to wit:

Maintenance and Other Operating Expenses	
Office Supplies Expenses	PHP35,000.00
Gasoline, Oil and Lubricants Expenses	5,000.00
Repair and Maintenance-Office Equipment	5,000.00


