“RESOLVED, To approve the foregoing request of the Honorable Mayor and to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 46

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP200,000.00 REPRESENTING SAVINGS IN CURRENT APPROPRIATION FOR IT EQUIPMENT AND SOFTWARE OF THE OFFICE OF THE CITY CIVIL REGISTRY FOR THE COMPLETION OF THE 3RD FLOOR OF THE LAND BANK OF THE PHILIPPINES BUILDING (UNDER BOT MODE).

Be it ordained that:

SECTION 1. The amount of PHP200,000.00 representing savings in current appropriation for IT Equipment and Software of the Office of the City Civil Registry under the General Fund is hereby re-appropriated for the completion of the 3rd Floor of the Land Bank of the Philippines Building (under BOT Mode).


SECTION 2. This Ordinance shall take effect after compliance with the provisions of R.A. 7160, the Local Government Code of 1991.
