"RESOLVED, To approve the foregoing request and to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 48

AN ORDINANCE REVERTING THE AMOUNT OF PHP300,000.00 REPRESENTING SAVINGS FROM THE CONTINUING APPROPRIATIONS OF THE OFFICE OF THE CITY PLANNING AND DEVELOPMENT COORDINATOR TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR THE PAYMENT OF CONSULTANCY FEE IN THE FORMULATION OF THE BAYAWAN CITY COMPREHENSIVE MASTER PLAN.

Be it ordained that:

SECTION 1. The amount of PHP300,000.00 representing savings from the following continuing appropriations of the Office of the City Planning and Development Coordinator, to wit:

Motor Vehicles	PHP165,000.00
Office Equipment	90,000.00
Other Equipment	45,000.00

is hereby reverted to the Un-appropriated Balance of the General Fund and to re-appropriate the same for the payment of Consultancy Fee in the formulation of the Bayawan City Comprehensive Master Plan.


SECTION 2. This Ordinance shall take effect after compliance with the provisions of R.A. 7160, the Local Government Code of 1991.


