RESOLUTION NO. 401

“Letter dated May 4, 2023 of Mrs. Veronica Grace P. Mirafior, City Government Department Head I, requesting for the amendment of Resolution No. 797, Ordinance No. 34, series of 2022, of the Sangguniang Panlungsod, otherwise known as “AN ORDINANCE CREATING TWENTY-NINE (29) PLANTILLA POSITIONS IN THE CITY HEALTH OFFICE AND ONE (1) PLANTILLA POSITION IN THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE OF THE LOCAL GOVERNMENT UNIT OF BAYAWAN CITY”, considering that some of the created positions are for National Government Offices hence, it could not be applied in the Local Government Unit.

“WHEREAS, considering the above circumstances, the Body deem it proper to abolish the two positions and to create new positions that is allowed under Civil Service Qualification Standards for Local Government Units.

“WHEREFORE, on motion of Honorable Councilor Nico Angelo L. Lim and duly seconded by Honorable Councilor Karl T. Saraña, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 24

AN ORDINANCE ABOLISHING TWO POSITIONS UNDER THE CITY HEALTH OFFICE AND CREATING TWO ADDITIONAL POSITIONS IN LIEU OF THE ABOLISHED POSITIONS

Be it ordained that:

Section 1. The following positions are hereby abolished under the City Health Office

And to create two positions in lieu of the abolished positions:

Section 2. Duties and Responsibilities of the Positions Created

CITY HEALTH OFFICE

Laboratory Technician II (CHO-30.1) SG 8

- 25% Performs various laboratory tests such as hematology, fecalysis, and urinalysis;
- 20% Monitors the activities involved for a laboratory analysis such as the preparation of chemical reagents and other medical microscopic examinations and specimens;
- 15% Trains subordinates on laboratory equipment operation and laboratory analysis research;
- 20% Monitors the cleanliness and upkeep of laboratory equipment and area;
- 15% Reviews and ensures accuracy of laboratory results prior to release;
- 5% Performs other related functions as may be assigned.

Laboratory Technician II (CHO-30.2) SG 8

- 25% Performs various laboratory tests such as hematology, fecalysis, and urinalysis;
- 20% Monitors the activities involved for a laboratory analysis such as the preparation of chemical reagents and other medical microscopic examinations and specimens;
- 15% Trains subordinates on laboratory equipment operation and laboratory analysis research;
- 20% Monitors the cleanliness and upkeep of laboratory equipment and area;
- 15% Reviews and ensures accuracy of laboratory results prior to release;
- 5% Performs other related functions as may be assigned.


SECTION 3. This ordinance shall take effect after compliance with the provision of R.A. 7160 of the Local Government Code of 1991.




