ORDINANCE NO. 22

AN ORDINANCE TEMPORARY CLOSING THE SPACE PERPENDICULAR TO THE BOYCO GYM/BOULEVARD ROAD STARTING CORNER C.M. RECTO STREET TO CORNER H. BOLLOS STREET AND MAGSAYSAY STREET CORNER GAMBOA STREET ON JUNE 23-24, 2018 IN LINE WITH THE BARANGAY FIESTA ACTIVITIES

Be it ordained that:

Section 1. The space perpendicular to the Boyco Gym/Boulevard road starting corner C.M. Recto Street to corner H. Bollos Street and Magsaysay Street corner Gamboa Street is hereby temporarily closed on June 23-24, 2018 in line with the Barangay Fiesta Activities.

Section 2. This ordinance shall take effect after the compliance with the provision of R.A. 7160, the LGC of 1991.


