APPROPRIATION ORDINANCE NO. 26

Be it ordained that:

Section 1. The amount of PHP5,000,000.00 representing savings in continuing appropriations under the Disaster Risk Reduction Management Fund CY 2011 is hereby reverted to the un-appropriated balance of the General Fund and re-appropriate the same for the construction of Kalumboyan Bridge.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.




