

“RESOLVED, To approve the foregoing request of the Honorable Mayor and to enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 28

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP70,000.00 REPRESENTING SAVINGS IN CURRENT APPROPRIATION FOR FAMILY PLANNING PROGRAM UNDER THE GENERAL FUND OF THE CITY HEALTH OFFICE TO MEDICAL, DENTAL & LABORATORY EQUIPMENT OF THE SAID OFFICE.

Be it ordained that:

Section 1. The amount of PHP70,000.00 representing savings in current appropriation for Family Planning Program of the City Health Office under the General Fund is hereby re-appropriated to Medical, Dental & Laboratory Equipment of the said office.

Section 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.
