ORDINANCE NO. 55

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP5,000.00 REPRESENTING SAVINGS IN CURRENT APPROPRIATION FOR REPAIR AND MAINTENANCE-TECHNICAL AND SCIENTIFIC EQUIPMENT OF THE CITY HEALTH OFFICE FOR REPAIR AND MAINTENANCE-MEDICAL, DENTAL AND LABORATORY EQUIPMENT OF THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP5,000.00 representing savings in current appropriation for Repair and Maintenance-Technical and Scientific Equipment of the City Health Office is hereby re-appropriated for Repair and Maintenance-Medical, Dental and Laboratory Equipment of the said office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.
