“On motion of Honorable Councilor Francisco T. Diao and duly seconded by Honorable Councilor Cabanban, the Council


“RESOLVED, To approve the foregoing request of the City Mayor and to enact, as it hereby enacts the following ordinance, to wit:

AN ORDINANCE NO. 68

AN ORDINANCE REVERTING THE AMOUNTS OF PHP53,990.40 AND PHP6,009.60 REPRESENTING OBLIGATED APPROPRIATION AND CONTINUING APPROPRIATION RESPECTIVELY, UNDER SANGGUNIANG PANLUNGSOD RESOLUTION NO. 406, ORDINANCE NO. 30, SERIES OF 2005 FOR THE PURCHASE OF FIREARMS FOR THE CITY LEGAL OFFICER WHICH WAS DISALLOWED BY THE SANGGUNIANG PANLALAWIGAN IN IT’S RESOLUTION NO. 362 DATED MARCH 30, 2006 UNDER TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR THE PURCHASE OF FIREARMS UNDER THE OFFICE OF THE MAYOR.

Be it ordained that:

SECTION 1. The amounts of PHP53,990.40 and PHP6,009.60 representing obligated



appropriation and continuing appropriation respectively, under Sangguniang Panlungsod Resolution No. 406, Ordinance No. 30, series of 2005 for the purchase of firearms for the City Legal Officer which was disallowed by the Sangguniang Panlalawigan in its Resolution No. 362 dated March 30, 2006 is hereby reverted to the Unappropriated Balance of the General Fund and re-appropriate the same for the purchase of Firearms under the Office of the Mayor.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


