 SECTION 1. The amount of PHP30,000.00 representing savings in current appropriations for office supplies expenses of the City Public Safety Office is hereby re-appropriated for traveling expenses of the same office.

SECTION 2. This Ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.
