RESOLUTION NO. 534

“WHEREAS, there is a need to open various one way streets of the city in order to decongest the traffic situation that is brought about by the present road construction that is on-going along the national highway;

“WHEREAS, the Body believed that opening certain one way streets and declaring the same as no parking areas will be beneficial to the motoring public since, this will hasten the traffic flow that is brought by the detours that were designated as an alternate route from the national highway.

“WHEREFORE, on motion of Honorable Councilor Lim and duly seconded by Honorable Councilor Lamis, the Council

“RESOLVED, To enact, as it hereby enacts the following Ordinance, to wit:

ORDINANCE NO. 32

AN ORDINANCE TEMPORARILY OPENING R. T. DIAO STREET FROM CORNER MABINI STREET TO C.M. RECTO STREET AS TWO WAY LANE AND DECLARING THE SAME AS NO PARKING ZONE TO ALL TYPES OF VEHICLE UNTIL SUCH TIME THAT THE ON-GOING ROAD CONSTRUCTION ALONG THE NATIONAL HIGHWAY WILL BE COMPLETED.

Be it ordained that:

SECTION 1. R. T. Diao street from corner Mabini Street to C.M. Recto Street is hereby temporarily declared as two way lane street and declaring the same as no parking zone to all types of vehicle until such time that the on-going road construction along the national highway will be completed.

SECTION 2. This ordinance shall take effect after the approval of the Local Chief Executive.




