“Third and Final Reading of an ordinance amending Section 5, of Ordinance No. 14, series of 1995, otherwise known as the Municipal Traffic Code

“On motion of Honorable Councilor Lim and duly seconded by Honorable Councilor Carreon, the Council

“RESOLVED, To enact, as it hereby enacts the following Ordinance, to wit:

ORDINANCE NO. 47

AN ORDINANCE AMENDING SECTION 5,
OF ORDINANCE NO. 14, S. 1995. OTHERWISE
KNOWN AS THE MUNICIPAL TRAFFIC CODE.


Be it ordained that:

SECTION 1. Section 5 of Ordinance No.14, S. 1995 is hereby amended and to read as follows:

“ SECTION 5. ONE WAY Traffic Streets: From 6:00 AM to 7:00 PM

- a. Along Claro M. Recto Street from corner J.P. Rizal Street to corner National Highway from South to North.
- b. Along Magsaysay Street from corner National Highway to corner J.P. Rizal Street from North to South.
- c. Along J.P. Rizal Street from corner Magsaysay Street to corner Claro M. Recto Street from West to East.
- d. Along R.T. Diao Street from corner Mabini Street to corner C.M. Recto Street from West to East.
- e. Along Mabini Street from Corner J.P. Rizal Street to corner C. Gamboa Street from North to South.

SECTION 2. Effectivity. This Ordinance shall take effect upon its approval.
