“RESOLVED, To approve the foregoing request and to enact, as it hereby enacts the following ordinance, to wit:

**ORDINANCE NO. 78**

AN ORDINANCE TEMPORARILY CLOSING A PORTION OF MAYOR NONOY BOLLOS STREET FROM THE JUNCTION OF THE NATIONAL HIGHWAY TO MAYOR SEVERINO MARTINEZ STREET TO ALL VEHICULAR TRAFFIC EFFECTIVE NOVEMBER 20, 2006 UNTIL JANUARY 3, 2006.

SECTION 1. A portion of Mayor Nonoy Bollos Street from the junction of the National Highway to Nene Martinez Street is hereby temporarily closed to all vehicular traffic from November 16, 2006 to January 3, 2007 for the duration of the celebration of the Pasko sa Bayawan and the 2006 Charter Day Celebration.

SECTION 2. This Ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.
