AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP52,181.80 REPRESENTING SAVINGS FROM VARIOUS CONTINUING APPROPRIATIONS OF THE OFFICE OF THE CITY CIVIL REGISTRY AND REVERTING THE AMOUNT OF PHP6,849.20 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION UNDER THE CAPITAL OUTLAY FOR IT EQUIPMENT ALSO OF THE SAID OFFICE TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND AND TO REAPPROPRIATE THE TOTAL AMOUNT OF PHP 59,031.00 FOR FURNITURES AND FIXTURES OF THE OFFICE OF THE CIVIL REGISTRY.

Is hereby re-appropriated and the amount of PHP6,849.20 representing savings in continuing appropriation under the capital outlay for IT Equipment also of the said office is also hereby reverted to the un-appropriated balance of the general fund and re-appropriate the above total amount of PHP 59,031.00 for furniture and fixtures of the Office of the Civil Registry.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


