“Presented for Third and Final Reading of An Ordinance creating the positions of Thirteen (13) Local Legislative Staff Assistant I with Salary Grade 6/1 in the Office of the Sangguniang Panlungsod, this city and providing funds thereof.

On motion of Honorable Councilor Duque and duly seconded by Honorable Councilor Trias, the Council

RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 1

AN ORDINANCE CREATING THE POSITIONS OF THIRTEEN (13) LOCAL LEGISLATIVE STAFF ASSISTANT I WITH SALARY GRADE 6/1 IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, THIS CITY AND PROVIDING FUNDS THEREOF.

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Bayawan, Province of Negros Oriental, that:

SECTION I. Title – This Ordinance shall be known as An Ordinance Creating the Positions of Thirteen (13) Local Legislative Staff Assistant I with Salary Grade 6/1 in the Office of the Sangguniang Panlungsod, this city and Providing Funds Thereof.

SECTION II. Purpose and Objectives: - This Ordinance is aimed to improve the services of the Office of the Sangguniang Panlungsod and enhance its efficiency in pursuit of maximizing the Legislative capability not only of the office but also of its individual members towards fulfillment of the goals set forth by this Local Government Unit for the welfare of its constituents.

SECTION III. Positions to be created:

I. OFFICE

a) Office of the Sangguniang Panlungsod

II. POSITIONS in the Office of the SANGGUNIANG PANLUNGSOD

POSITION	SALARY GRADE	MONTHLY RATE	NO. OF EMPLOYEE
a) Local Leg. Staff Asst. I	SG-6/1	PHP12,275.00	Thirteen (13)

SECTION IV. General Requirements, Qualifications, Salary and Other Emoluments – all applicants to the positions as provided for in this ordinance must be:

- a) A resident of Bayawan City
- b) A holder of the proper educational attainment, training, experience or eligibility as provided for in the Qualification Standards set forth by the Civil Service Commission.
- c) Qualified to receive a salary and other emoluments equivalent to the salary grades provided for the qualification standards set forth by the Civil Service Commission.

SECTION V. Co-Terminus Positions. – Co-Terminus employees shall within the term of office of the appointing officer. Provided however, that subject to majority vote of the members thereof, the Sangguniang Panlungsod may formulate additional guidelines in the hiring of co-terminus employees that shall automatically form part of this ordinance. As provided for in this ordinance, the following positions are considered co-terminus:

- a) Local Legislative Staff Assistant I. – Under the Office of the Sangguniang Panlungsod

SECTION VI – Funding Requirements – There shall be appropriated the total amount of PHP2,946,632.00 out of the Un-appropriated Balance of the General Fund for CY 2015 particularly of the Office of the Sangguniang Panlungsod, to wit:

SECTION VII – Effectivity Clause – This ordinance shall take effect immediately after this approval.




