RESOLUTION NO. 632

“Third and Final Reading of An ordinance creating the Council for Culture and the Arts in the City of Bayawan, Negros Oriental, Philippines.

“WHEREAS, the provisions of Sections 447 (5) (XVI) , 458 (5) (XVI) and 438 (4) (VII) vest upon the local sanggunians the power to establish local councils in order to promote culture and arts.

“WHEREAS, it is high time that in every locality Culture and Arts must be given high attention to foster its development and promotion.

“On motion of Honorable Councilor Recamara and unanimously seconded by all the members present, the Council

“RESOLVED, To enact, as it hereby enacts the following Ordinance.

ORDINANCE NO. 36

AN ORDINANCE CREATING THE COUNCIL FOR
THE CULTURE AND THE ARTS IN THE
CITY BAYAWAN, NEGROS ORIENTAL,
PHILIPPINES

Be it ordained that:

SECTION 1. There is hereby created the Culture and the Arts Council of the City of Bayawan headed by the City Chief Executive with the following composition, to wit:

- a. A representative from the Local Tourism Council
- b. Chairman of the Sangguniang Panlungsod Committee on Culture and Arts or the equivalent
- c. City Cultural Officer or the equivalent
- d. City Planning and Development Coordinator
- e. City Information Officer
- f. Local Budget Officer
- g. Officer of the Historical/Conservation/Heritage Society (if any)
- h. One (1) representative each from the Indigenous peoples and Cultural Committees existing in Bayawan territorial jurisdiction
- i. One (1) representative from the private sector



j. Five (5) other members appointed/designated by the City Chief Executive

SECTION 2. The City Culture and Arts Council shall have the following functions:

- a. Prepare an annual plan on culture and the arts consonant to the Medium Term Philippine Development Plan for Culture and Arts, to be integrated in the Local Development Plan.
- b. Formulate programs and recommendations to develop local cultural and artistic talents.
- c. Ensure the protection, preservation and conservation of the local cultural historical heritage.
- d. In coordination with the private sector, conduct cultural event such as cultural festivals, competition, lectures, seminars, for a symposia, set up exhibits during fiestas and other related activities.
- e. Conduct periodic consultations with all stakeholders to identify grassroots-based cultural concerns, issues and agenda.
- f. Encourage the development of local conduct periodic inventory cultural industries.
- g. Conduct periodic inventory of local cultural objects and sites in coordination with the National Commission for Cultural and The Arts.
- h. Coordinate with existing Local Cultural and The Arts Councils.
- i. Other functions, as the City Chief Executives may designate, related to promotion and development of Culture and The Arts.

SECTION 3. Meetings. The Council shall meet once in every quarter of the year. Other than the regular meetings the chairman may call the council as often as necessary.

SECTION 4. Repealing Clause. Provisions of ordinances or resolutions inconsistent herewith are hereby repealed or modified accordingly.


SECTION 5. This ordinance shall take effect upon compliance with the provisions of R. A. 7160.


