The total amount of ₱11,000,000.00 out of the above-mentioned funding source under Section 1 is hereby appropriated for the payment of COVID-19 Hazard Pay to Local Government Employees & Special Risk Allowance to Frontline Public Health Workers pursuant to Budget Circular No. 2020-1 dated March 24, 2020 & Administrative Order Nos. 26 and 28 dated March 23, 2020 and April 6, 2020 respectively, to wit:
