Macajilos, Executive Assistant III of the Office of the City Mayor, as contact person to Land Bank of the Philippines and Monetary Board in processing of loans intended to finance LGU’s development projects/programs.

ORDINANCE NO. 46

AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY OF BAYAWAN, IN THE AMOUNT OF FOUR HUNDRED FIFTY MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P 450,500,000.00) TO FUND THE VARIOUS INFRASTRUCTURE PROJECTS OF THE CITY.

Be it ordained that:

SECTION 1. The City Mayor, in representation of the City, hereinafter referred to as the “City”, is hereby authorized to enter into LOAN TO FINANCE VARIOUS INFRASTRUCTURE PROJECTS with LAND BANK OF THE PHILIPPINES (LBP) in accordance with Section 297 of Republic Act No. 7160 of the Local Government Code, in the amount of FOUR HUNDRED FIFTY MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P 450,500,000.00) under the terms and conditions herein set forth and such other terms and condition as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the City Mayor shall have full power authority to represent the City in negotiating the terms and conditions for the said borrowing and in signing, executing and delivering such agreements, contracts, deeds, papers and documents as maybe necessary and proper for the full and total implementation of the authority herein granted;

SECTION 2. The said priority projects herein specified as the 1) LGU Counterpart for the Construction of Sport Complex 2) Concreting of Maninihon–Cansumalig–San Isidro FMR 3) Concreting of Dawis –Lapay FMR 4) Concreting of Narra-Ohot FMR 5) Concreting of Tabuan – Dita–Gamao FMR 6) Concreting of Minaba–Tayawan–Kalumboyan FMR 7) Concreting of Tabuan–Banaybanay-Lapay –Bugay FMR 8) Concreting Pulangyuta- Lapay FMR 9) Improvement of Hinake-Camandagan FMR 10) Concreting of San Jose-Manduaao FMR 11) Concreting of Tavera- Narra Proper FMR are hereby certified to be a local infrastructure and/or other socio-economic development projects in accordance with the approved local development plan and annual investment program for 2020 of the City and is supported by a final Program of Work and Detailed Engineering Design for Road Development Projects and the Establishment of Bayawan-NORSU Sport Complex.

SECTION 3. Consistent with the covering loan agreement, contract, deeds and assignment, mortgage contracts, and such other agreements as maybe entered into by the City in connection with the borrowing, the features, terms and conditions are hereby approved:

3.6 Concreting of Minaba –Tayawan –Kalumboyan FMR	20,000,000.00
3.7 Concreting of Tabuan –Banaybanay-Lapay –Bugay FMR	21,500,000.00
3.8 Concreting Pulangyuta- Lapay FMR	20,000,000.00
3.9 Improvement of Hinake- Camandagan FMR	60,000,000.00
3.10 Concreting of San Jose -Manduaao FMR	21,500,000.00

SECTION 4. The City hereby appropriates the entire proceeds of the borrowing exclusively to finance the VARIOUS INFRASTRUCTURE PROJECTS and other financial obligations relative thereto.

SECTION 5. Any Ordinance or parts thereof, inconsistent with this enactment is hereby replaced or amended accordingly.

SECTION 6. This Ordinance shall take effect upon its compliance with all procedures required under Republic Act No. 7160, the LGC of 1991.



ORDINANCE NO. 46

AN ORDINANCE AUTHORIZING THE BORROWING OF THE CITY OF BAYAWAN, IN THE AMOUNT OF FOUR HUNDRED FIFTY MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P 450,500,000.00) TO FUND THE VARIOUS INFRASTRUCTURE PROJECTS OF THE CITY.

Be it ordained that:

SECTION 1. The City Mayor, in representation of the City, hereinafter referred to as the “City”, is hereby authorized to enter into LOAN TO FINANCE VARIOUS INFRASTRUCTURE PROJECTS with LAND BANK OF THE PHILIPPINES (LBP) in accordance with Section 297 of Republic Act No. 7160 of the Local Government Code, in the amount of FOUR HUNDRED FIFTY MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P 450,500,000.00) under the terms and conditions herein set forth and such other terms and condition as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402.
