Be it ordained that:

SECTION 1. The amount of PHP10,000.00 representing savings in current appropriation for Postage and Deliveries under the General Fund of the Office of the Regional Trial Court for Office is hereby re-appropriated for Supplies Expenses of the said office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R.A. 7160, the Local Government Code of 1991.
