RESOLUTION NO. 66

“WHEREAS, pursuant to the promotion of Senior Citizen Welfare and their involvement in the implementation of programs and services for the elderly persons and on the formulation of policies for their reciprocal benefit and that our local government, we acknowledge along with the Office of the Senior Citizens Affairs (OSCA), the existence of the Bayawan City Federation of Senior Citizens Association of the Philippines, Inc.;

“WHEREAS, the Chapter Presidents of the Bayawan City Federation of Senior Citizen Association of the Philippines, Inc. are task to perform activities not limited to execute as leaders in their respected assigned areas, submit records of all its members and that records must be available to the Office of the Senior Citizens Affairs (OSCA) and DSWD Staff upon request, to serve as general information and liaison for Senior Citizens in the Barangay level, to plan, implement and monitor yearly work programs for Senior Citizens in the Barangay level, and encourage fellowship and social bonding among the members;

“WHEREAS, under the implementing rules and regulations of R.A. 9994, “AN ACT GRANTING ADDITIONAL BENEFITS AND PRIVILEGES OF SENIOR CITIZENS” only the head of the OSCA is entitled to receive honorarium;

“WHEREAS, the same law wits implementing rules does not prescribe or prevent other officers from receiving reasonable honorarium as may be allowed by the local government unit concerned;

“WHEREAS, acknowledging the rights of all the Chapter Presidents of the Bayawan City Senior Citizen Federation Association of the Philippines, Inc. who had not been painstakingly and religiously doing their duties and responsibilities, but also felt the urgent need to augment their finances in performing their job functions to regularly attend meeting in the City level and conduct the same to their respective Barangays;

“WHEREAS, there is a portion of the City appropriation especially allocated to Senior Citizens which could be the source of reasonable honorarium for the Chapter Presidents of the Bayawan City Federation of Senior Citizen Association of the Philippines, Inc., to wit:

“NOW THEREFORE, on motion of Honorable Councilor Jamin and duly seconded by Sumalpong, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

### ORDINANCE NO. 3

AN ORDINANCE INSTITUTIONALIZING BAYAWAN CITY FEDERATION OF SENIOR CITIZEN ASSOCIATION OF THE PHILIPPINES, INC. AND PROVIDING MONTHLY CASH ASSISTANCE TO EVERY CHAPTER PRESIDENT THEREOF

Be it ordained that:

Section 1. This ordinance shall be known as AN ORDINANCE INSTITUTIONALIZING BAYAWAN CITY FEDERATION OF SENIOR CITIZEN ASSOCIATION OF THE PHILIPPINES, INC. AND PROVIDING MONTHLY CASH ASSISTANCE TO EVERY CHAPTER PRESIDENT THEREOF

Section 2. Bayawan City Federation of Senior Citizen Association of the Philippines (BCFSCAP) Chapter presidents are those knowledgeable, legally identified Senior Citizen’s duly elected/appointed and certified by BCFSCAP to perform their functions, duties and responsibilities;

#### 2.1 Functions, Duties and Responsibilities of Senior Citizen Presidents:

- Attends BCFSCAP regular monthly meetings every second Friday of the month, emergency meetings called for at the (OSCA Office) office of the Senior Citizen Affair Bayawan City
- Submit reports on programs, project and activities as necessary required by the Federation
- Provides Monthly regular meeting as per barangays schedule, emergency meetings
- And echo and discussed what was discussed during BCFSCAP meeting
- Follow the constitution and bylaws of the BCFSCAP Association
- Plan/implement activities, projects and resolutions agreed during the meeting
- Create linkages and seek funds for the benefit of Senior Citizen Chapter Association
- Follow-up social pensioners in their respective residence during their schedule of payout per chapter
- Submit registration forms of Senior Citizen and PhilHealth application for processing
- Set guidelines for monthly dues, mortuary fees, etc.
- Do other tasks assigned by the federation.

Composition:



- 2.2 BCFSCAP, INC. is composed of 31 Chapter Presidents
  - The 31 chapter presidents are automatically members of the (BOD) Board of Directors
  - Among the BOD officers are being elected
- 2.3 Classification and Members of Chapter
  - a. Urban Barangays – 7 Chapters
  - b. Rural Barangays – 24 Chapters
  - Total = 31 Chapters

Section 3. Funds

- 3.1 Amount Allocation: PHP372,000.00
- 3.2 Purpose of Allocating Funds: the amount in the form of monthly cash assistance for Senior Citizen Chapter Presidents shall be utilized to defray Senior Citizen related activities as to their functions, duties and responsibilities.
- 3.3 Source of funds: Approved Annual Budget of the Local Government Unit of Bayawan City.

Section 4. Implementation. The Office of the City Social Welfare in coordination with the Local Chief Executive is hereby authorize to implement the provision of this ordinance.

Section 5. Effectivity. This Ordinance shall take effect immediately upon approval thereof in accordance with the law

“Enacted.”
