“Third and Final Reading of An Ordinance adopting the parking plan for all vehicles and motorcycles parked within the premises of Bayawan City Hall and prescribing penalties and violation thereof.

“On motion of Honorable Councilor Tijing and duly seconded by Honorable Councilor Sumalpong, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 5

AN ORDINANCE ADOPTING THE PARKING PLAN FOR ALL VEHICLES AND MOTORCYCLES PARKED WITHIN THE PREMISES OF BAYAWAN CITY HALL AND PRESCRIBING PENALTIES AND VIOLATION THEREOF

Be it ordained that:

Section 1. There is hereby a parking plan for all service vehicles and motorcycles within the premises of Bayawan City Hall of which a copy of the plan attached and marked as annex “A” and made an integral part of the ordinance.

Section 2. Only four wheeled vehicles are allowed to get inside and park in the premises of Bayawan City Hall.

Section 3. Only vehicles, personally owned or LGU owned but assigned as service vehicles to the elected officials, from the Mayor to the City Councilors, Barangay Captains and Barangay Kagawads, clients and visitors, authorized delivery vans and motorized tricycle delivering goods to the City can park inside the premises of the Bayawan City Hall.

Section 4. Four wheeled vehicles, e-bikes and bicycles personally owned or LGU owned vehicles assigned as service vehicles to the LGU Department Heads or personnel,

National Government Agencies and private organization can park at the side of the LGU Gymnasium along Gomez St. An entrance gate at the back portion of the LGU Gymnasium will be provided for the holder, owner, driver, passenger of these vehicles.

Section 5. All service motorcycles of LGU personnel, National Agencies, private people can park in the designated motorcycle area, outside the LGU premises adjacent to the entrance gate which is still considered with the premises of LGU Bayawan City.

Section 6. Immediately beyond the fence of the Bayawan City Hall Compound, left portion of Bollos St. going to mark plywood will be utilized also as parking area for four wheels vehicles and motorcycles for the public. A designated area will be mark by the Engineering Department personnel for four wheeled vehicles and motorcycles.

Section 7. Immediately beyond the fence of the City Hall Compound, left portion of Mabini St. going to Land Bank of the Philippines, from the intersection of Gomez St. and Mabini St. up to the vehicle water refilling area, can be used as parking area for four wheeled vehicles and motorcycles for the public, a designated area for the four wheeled vehicles and motorcycles will be provided by the City Engineering personnel.

Section 8. Implementing Office. The City Public Safety Office (CPSO) is hereby tasked to implement this ordinance.

Section 9. Penalty Clause. Any person or persons found violating this Ordinance shall be punishable with the following fines, to wit:

1 st Offense	-	First Warning
2 nd Offense	-	Second Warning
3 rd Offense	-	Fine of One Hundred Pesos (PHP100.00)
4 th & succeeding Offenses	-	Fine of Two Hundred Pesos (PHP200.00)


Section 10. This ordinance shall take effect after compliance with the provision of R.A. 7160, the Local Government Code of 1991.




