RESOLUTION NO. 737

“Presented for consideration Resolution No. 382, current series, of the Sangguniang Panlalawigan of Negros Oriental returning to the Body Resolution No. 103, current series, of the Sangguniang Panlungsod of Bayawan, this province, enacting Ordinance No. 2, creating (40) Casual positions, Salary Grade 1, at Php8,550.00 per month, under the Support Services of the City Mayor’s Office, and providing funds thereof, inviting attention to the comment of the Human Resource Management Officer IV embodied in her 2<sup>nd</sup> Indorsement dated March 30, 2015 commenting that subject positions are not in accordance with Local Budget Circular No. 61 of the Department of Budget and Management dated March 18, 1996;

WHEREAS, the Honorable Mayor Ismael P. Martinez in his letter dated September 10, 2015 has requested the Honorable Sangguniang Panlungsod to amend the creation of 40 casuals positions to 40 Administrative Aide I (Utility Worker I) positions with corresponding daily wage of Php388/day anchored on Salary Grade 1, to conform to the index of position titles as stipulated in LBC No. 61.



On motion of Honorable Councilor Trias and duly seconded by Honorable Councilor Tijing, the Council

RESOLVED, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 48

AN ORDINANCE CREATING THE POSITION OF FORTY (40) ADMINISTRATIVE AIDE I (UTILITY WORKER I) UNDER THE SUPPORT SERVICES OF THE OFFICE OF THE CITY MAYOR AND APPROPRIATING FUNDS THEREOF.

Be it ordained that:



SECTION 1. There shall be created the positions of Forty (40) Administrative Aide I (Utility Worker I) under the Support Services of the Office of the City Mayor and appropriating funds thereof.

SECTION 2. There shall be appropriated the total amount of PHP6,781,320.00 out of the Un-appropriated balance of the General Fund for the following:


