ORDINANCE NO. 45

Be it ordained that:

Section 1. A portion of the Coastal Road from the end of the island near Julsam’s Bakeshop and Restaurant until the island’s other end near Pepe’s Place is hereby temporarily close on December 3, 2021 from 5 o’clock in the afternoon until 6 o’clock in the morning of December 4, 2021 during Pepe’s Night at Pepe’s Place as part of the 21<sup>st</sup> Charter Day Celebration and Pasko sa Bayawan.

Section 2. This ordinance shall take effect after the approval of the Local Chief Executive.
