Be it ordained that:

Section 1. A portion of Claro M. Recto Street to corner J.P. Rizal Street, Barangay Tinago is hereby temporarily close on December 19, 2017 at 6:00 P.M. to 2:00 AM of December 20, 2017 for the Annual Christmas Party of the Fresh Fish Vendors Association of Bayawan City Public Market (Fresh Venas).


