“WHEREAS, Proclamation No. 240 on the Philippine Decade of Disabled Persons 2003-2012 instructs all Heads of Departments, Chiefs of Bureaus, Offices, Agencies and Instrumentalities of the National Government, Local Government Units to implement plans, programs and activities geared towards the Development of Persons with Disability;

“WHEREAS, RA 7277 otherwise known as the Magna Carta for Disabled Persons, An Act providing for the Rehabilitation, Self-development and Self-reliance of Disabled Persons and their Integration to the Mainstream of Society and for other purposes under Title II Rights and Privileges of Disabled Persons, Chapter IV provides that the State shall ensure that marginalized persons with disability are provided with necessary auxiliary services that will restore their social functioning and participation in the community;

“WHEREAS, Section 16 of general welfare clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its effective governance and those which are essentials to the promotion of general welfare;

“NOW THEREFORE, on motion of Honorable Councilor Gaudiel and duly seconded by Honorable Councilor Tijing, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance :

ORDINANCE NO. 62

AN ORDINANCE ALLOCATING ONE HUNDRED THOUSAND PESOS EACH YEAR AS CASH ASSISTANCE TO PURCHASE REHABILITATIVE EQUIPMENT FOR DESERVING PERSONS WITH DISABILITY OF BAYAWAN CITY.

Be it ordained that:

Section I. This ordinance shall be called and known as AN ORDINANCE ALLOCATING ONE HUNDRED THOUSAND PESOS EACH YEAR AS CASH ASSISTANCE TO PURCHASE REHABILITATIVE EQUIPMENT FOR DESERVING PERSONS WITH DISABILITIES OF BAYAWAN CITY.

Section II. There shall be an annual allocation of One Hundred Thousand Pesos (PhP100,000.00) taken from the regular budget of the City Social Welfare & Development Office (CSWDO) that shall be intended for Cash Assistance to deserving PWDs of Bayawan City. The Cash assistance shall only be intended to purchase rehabilitative & mobility equipment and accessories for Persons with Disabilities (PWDs).

Section III. The Bayawan Federation of Persons with Disabilities (BFPWDs) shall submit the list of Persons with Disability qualified to avail of cash assistance for the purchase of rehabilitative equipment to the City Social Welfare and Development Office (CSWDO) in a first come first serve basis.

Section IV. Only persons with disabilities duly registered as bonafide members of BFPWD and resident of Bayawan City shall qualify to avail of the cash assistance from the City Government for the purchase of rehabilitative equipment based on the prescription or recommendation of the Doctor, such as, but not limited to wheelchair, walker, quad cane, hearing aid, prosthetic devices or any assistive/rehabilitative equipment that enhances mobility and functional limitations.

Section V. Each person with disability deserves to avail only once of the amount of Seven Hundred Pesos (PhP700.00) up to Eight Thousand Pesos (PhP8,000.00), depending on the type and economic value of rehabilitative equipment, provided however, that the official receipts upon purchase shall be submitted to the City Social Welfare and Development Office for record and documentation purposes. In case the amount of rehabilitative equipment exceeds Eight Thousand Pesos, the person who shall avail of cash assistance shall counterpart to complete the amount for the purchase of said equipment. In case the cost of equipment purchased is less than the cash assistance received, the recipient is under obligation to return the excess amount to the City Treasurer's office.

Section VI. Only one (1) member of a family whom the PWD belongs shall avail only once of the cash assistance from the City Government.

Section VII. The CSWDO through its Focal Person for the Senior Citizens (SCs) and PWD Program shall assist and ensure that the utilization of the cash assistance is in accordance with the guidelines approved by the Sangguniang Panlungsod of this City.

Section VIII. Any violation of the concerned PWD in any of the stipulations in this guideline shall oblige the recipient PWD to return the cash assistance to the City government within two weeks after the City had known and validated/investigated the violation. A written report of the incident and findings shall be submitted to the CSWDO for appropriate action.

Section IX. Repealing clause. Any and all ordinances, executive orders and or proclamations of the City of Bayawan or parts thereof which are contrary to, or inconsistent herewith are hereby repealed, amended or modified accordingly.

Section X. Effectivity – This ordinance shall take effect after compliance with the provisions of RA 7160, the Local Government Code of 1991.






