AN ORDINANCE AMENDING THE OBJECT OF EXPENDITURES FOR CAPITAL OUTLAY-MOTOR VEHICLES OF THE OFFICE OF THE GENERAL SERVICES OFFICER UNDER RESOLUTION NO. 333, ORDINANCE NO. 10, CURRENT SERIES, BY AMENDING THE NUMBER OF UNITS OF STREET SWEEPER TRUCK TO BE ACQUIRED FROM TWO (2) UNITS TO ONE (1) UNIT

Be it ordained that:

Section 1. The Object of Expenditures for Capital Outlay-Motor Vehicles of the Office of the General Services Officer under Resolution No. 333, Ordinance No. 10, current series, is hereby amended by amending the number of units of Street Sweeper Truck to be acquired from Two (2) units to One (1) unit.


