“RESOLVED FURTHER, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 11

AN ORDINANCE REVERTING THE AMOUNT OF PHP2,000,000.00 REPRESENTING THE APPROPRIATION FOR THE DEVELOPMENT OF THE GOVERNMENT CENTER (CONCRETING) UNDER SUPPLEMENTAL NO. 6 CY 2005 (SANGGUNIANG PANLUNGSOD RES. NO. 314, ORDINANCE NO. 25) WHICH WAS CARRIED AS CONTINUING APPROPRIATION IN THE CURRENT YEAR UNDER THE GENERAL FUND TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR THE DEVELOPMENT OF GOVERNMENT CENTER (ROAD OPENING).

Be it ordained that:

SECTION 1. The amount of PHP2,000,000.00 representing the appropriation for the Development of the Government Center (concreting) under Supplemental No. 6 CY 2005 (Sangguniang Panlungsod Res. No. 314, Ordinance No. 25) which was carried as continuing appropriation in the current year under the general fund is hereby reverted to the un-appropriated balance of the general fund and re-appropriate the same for the Development of Government Center (Road Opening).


SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


