The amount of ₱700,000.00 representing savings in continuing appropriation under Special Purpose Appropriation – Grants and Aids, Other Purposes for Electrification Project at Sitio Camandagan, Barangay Maninohon is hereby reverted to the unappropriated balance of the General Fund and to appropriate the same for Electrification Project at Sitio Ayum, Barangay Maninohon under the Office of the City Engineer.

Section 2. This ordinance shall take effect after the approval of the Local Chief Executive.


